

## Visionic Runtime End-User License Agreement (EULA)

IMPORTANT-READ CAREFULLY: This Software License Agreement or "Agreement" is a legal agreement between you (either as an individual or as an agent for your company) and the INTOREL S.a.r.1 (INTOREL), which covers the usage of this computer SOFTWARE and related documentation together known as the "SOFTWARE PRODUCT" (VISIONIC RUNTIME ENGINE, containing both SERVER RUNTIME ENGINE and CLIENT RUNTIME ENGINE). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this AGREEMENT, promptly delete all copies of the SOFTWARE PRODUCT. If you have obtained an evaluation or unregistered copy of the SOFTWARE PRODUCT, you may evaluate the SOFTWARE PRODUCT for maximum 30 days without registering and/or purchasing the necessary license. After 30 days, you must either register and/or purchase the necessary license or remove all copies of the SOFTWARE PRODUCT.

## SOFTWARE PRODUCT LICENCE
